
In addition to earning a dual degree and a minor, I was a charter member of the Honors College and awarded summa cum laude for my academic achievements.

Oscar "Roby" Robinson's Retirement

May 23, 2017 marked the end of an era in the Aviation Ordnance community. Mr. Oscar J. "Roby" Robinson retired after almost 50 years of service to this country. Roby wore the uniform of an Airman, Petty Officer, Chief Petty Officer, and commissioned LDO for 25 years; then wore a coat and tie for 25 more as a civil servant. Roby was embedded on the staff of Commander, Naval Air Forces Atlantic as PEO/W Carriers. He was the lead on design, planning and implementation for CVN Weapons Department spaces for all Nimitz Class CVN hulls from USS ABRAHAM LINCOLN (CVN 72) through Ford Class CVN USS GERLAD R. FORD (CVN 78).

In a ceremony held at Mobile Ordnance Training Team (MOTT) building, Naval Station Norfolk, Ordie One CAPT Bill Bindel, guest speaker, presented Mr. Robinson with the Navy Superior Civilian Award. The citation reads:

NAVY SUPERIOR CIVILIAN SERVICE AWARD

TO

MR. OSCAR J. ROBINSON

for service as set forth in the following


For extraordinary service while serving as aircraft carrier (CVN) Weapons Air/Ship Integration and Fleet Modernization Program Manager on the staff of Commander, Naval Air Force, Atlantic from December 1992 to May 2017. Mr. Robinson's superb leadership and technical prowess in the management of CVN Shipboard Weapons Installation/Integration and Material Programs resulted in 26 new weapons systems delivered on time and within budget providing warfighters with the newest lethal kill systems in the Navy arsenal. As Fleet Weapons Modernization Program Manager, his team designed and developed an improved Upper Stage Weapons Elevator for USS RONALD REAGAN (CVN 76) and USS GEORGE H W BUSH (CVN 77), which reduced ammunition transit times by 25 percent. His technical expertise was instrumental in the design and construction of all NIMITZ class CVN 03-level Airborne Electronics Counter Measures Complexes. Additionally, as Air/Ship Integration Team lead, his efforts contributed directly to the Integration of the F/A-18, MH-60 (Sierra and Romeo) and F-35 aircraft to the CVN platform. This award is the culmination of over 48 years of dedicated government service to the Navy and the defense of our Nation, and is testament to the enduring contributions and countless personal sacrifices he made to preserve the freedoms and liberties all Americans cherish. Mr. Robinson's distinctive accomplishments and impressive devotion to duty reflected credit upon himself and the Department of the Navy.

After Roby's retirement ceremony, the presiding officer, CAPT Alan Dean, officially renamed the MOTT building to the "Oscar Robinson Ordnance Training Facility." A plaque with several photos of Roby along with his military and civilian biographies will hang on the Quarter Deck for future redshirts to read about Roby's legacy. No words, awards, or even the building named in his honor could ever properly recognize the contributions Mr. Robinson accomplished in his 50 year tenure. Roby Robinson's contributions will affect Red Shirts for decades to come.

On behalf of past, present and future Red Shirts, we proudly say "THANK YOU MR. ROBINSON" for your many sacrifices and for making our community greater. As you begin a new chapter in your life on the farm in Maine, we wish you and the entire Robinson Family nothing but health and happiness. Fair Winds and Following Seas! 

HOW TO BORESIGHT

NAS Quonset Point R.I. VF-72. Grumman Panthers F9F-2. Four 23MM Nose Cannons.

A plane was flown to NAF Charlestown, R I. and towed to the very primitive Boresight Butts. The Ordies went by bus.

A template was required and with six weeks of Algebra, plus basics from the Aircraft Manual one was made.

The aircraft was positioned, the Nose Strut partially depressurized, the aircraft was leveled to zero degrees elevation, the template was positioned 100 feet Down Range in line with the Aircraft Centerline Fixture. The aircraft was then tied down securely. The Gunsight and Gunswere adjusted to their spots on the template.

The dirt for the impact area was not very tall. There was the biggest Timber I ever saw in front of the dirt. Two feet square in cross section. I stepped back expecting to see one hole in its proper place on the template for each gun.

There was a tremendous roar! The Nose Strut collapsed, the Timber and template disappeared, hundreds of pounds of dirt filled the air, two hundred projectiles ricocheted over the Butts and headed for the highway.

Painful lessons learned. The aircraft should have been jacked. One round for each gun should have been loaded. Responsibility for those two failures was not spoken to. No one was punished and the other eleven aircraft went to Korea un-Boresighted.

Boresighting was never spoken of again.

Danger is always present in Ordnance work as you well kow. This incident could have turned into an accident, thank God it didn't. My only excuse is that I was the junior E-6 and there were three Chiefs in charge,










For those who may not know, a Tallboy is a medium capacity bomb, weighing 12,000LBS, and was an earthquake bomb developed by the British, and used by the RAF during the Second World War. The T-10 was an American-made version of the bomb and was modified to use standard American components. Development was started in late 1944, however, none were ever used, and they were shortly retired in 1955. No one knows why it was there, but either way we had to get rid of it. AO2 Cortez, Jose and AO2 Dzeidzic had the pleasure of escorting the bomb to the EOD explosive site. "It was a 'once in a lifetime' thing for me, and I have never seen a bomb that big! I was expecting a huge explosion once EOD put the C-4 on the body, but I was highly disappointed to only see a small dust cloud. Come to find out, it was inert. It was just a huge hunk of cement. I believe it took over five hours for them to try and crack that big boy open." said AO2 Cortez.
