Hey Kevin! Wanted to pass a "Bravo Zulu" to HSC-9, an MH-60S squadron assigned to CVW-8 and HSCWL, for their record setting expenditure of 915 unguided 2.75" Rockets during joint exercise JADED THUNDER 19-2 conducted at Salina KS, 2-14 August 2019. JSOC hosted the exercise and recognized HSC-9 for their Jaded Thunder "World Record" rocket expenditure by presenting them an impressive trophy for their work. Over eight fly days of which six were in support of JSOC units, HSC-9 flew 168 hours, expended 915 unguided rockets and qualified six pilots and re-qualified ten others. As we say in the U.S. Navy Helicopter Community, "Winchester".





Having spent 7 days with HSC-9 and their Gunner, CWO2 Brandon Hall, during the Det, I saw first-hand the pride, professionalism and proficiency of the Sailors of HSC-9 and the USS Gerald R. Ford (CVN -78) who expertly provided G Division support to HSC-9. In all, the CVN-78 G Division tested and built-up 74 LAU-61C/A Pods during the Det.

The primary purpose of Jaded Thunder was to integrate aviation assets into JSOC training scenarios where planning and execution occurred in a joint battlespace. Additionally, HSC-9 became the first USN Helo squadron to utilize "Fastpack" (NALC HA13) 2.75" rockets. Use of the HA13 Fastpack rockets very much simplified LAU-61C/A build up. Further, HA13 rockets would provide significantly decreased turn-around times during high-tempo ordnance operations.




We're back and we are doing amazing things as a Chapter and for our community!


