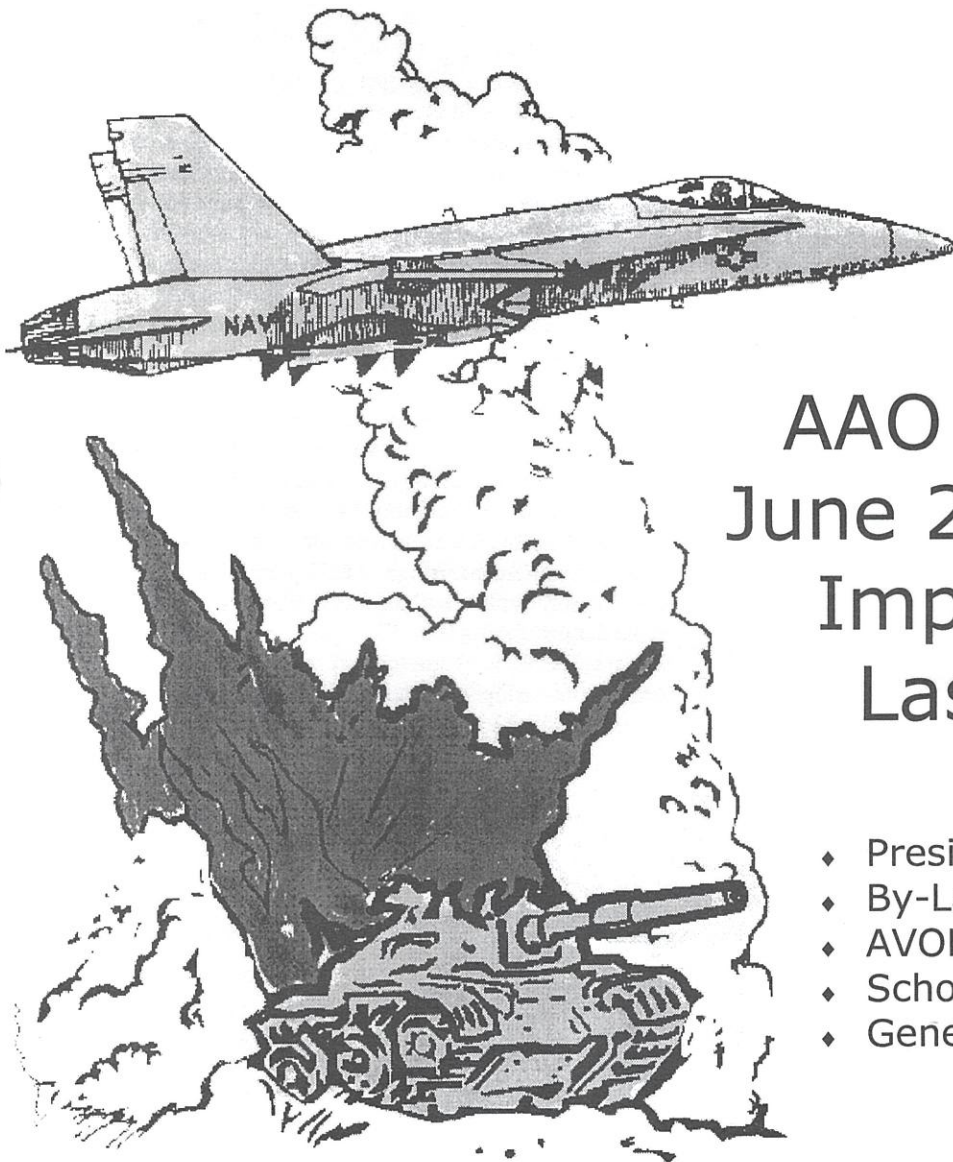

Each proposed change is provided separately rather than having them combined into one all encompassing change. This allows the general membership to vote for or against each proposal individually.

Because the majority of our membership cannot attend the convention each year, we believe that absentee voting would allow for greater participation. However, one of the biggest concerns in accepting absentee ballots for elections or motions was our continued ability to accept nominations from the floor at our general business meetings. The By-Laws committee, working very closely with the Board of Directors, was able to resolve these details.

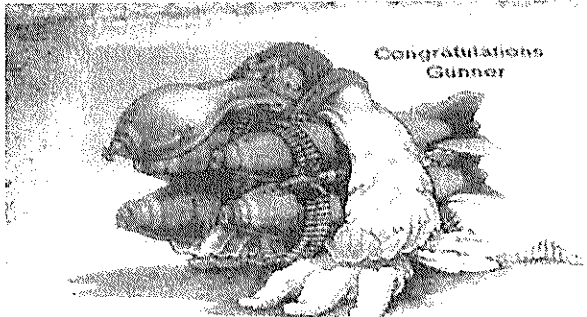

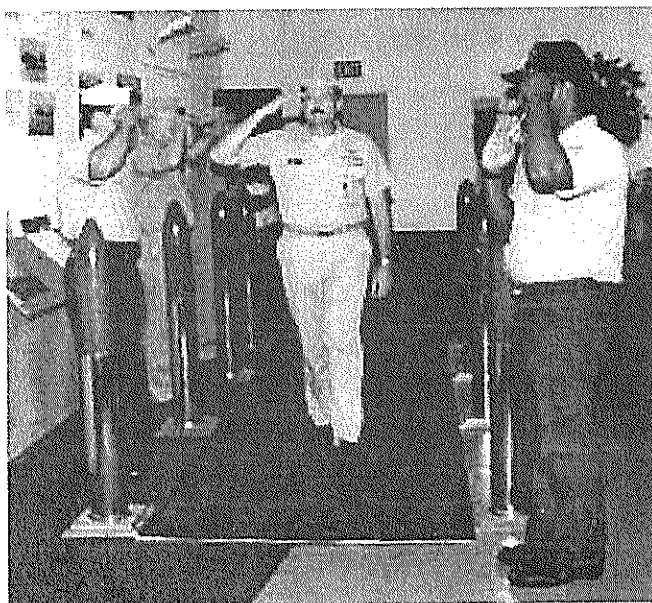

## Chapter 22 Patuxent River



On 22 October 1999 Chief Warrant Officer Lee A. Clark retired from the United States Navy. A large number of Association members gathered as our Chapter President, affectionately know as Bud, retired from active duty. Bud Clark enlisted in the Navy in June 1976 and reported to Boot Camp at Great Lakes Illinois. He attended AO "A" School at Millington Tennessee. In August of 1977 he reported for duty at the Weapons Department, Naval Air Station, Cecil Field, Jacksonville, Florida. In September 1979, AO3 Clark reported to VA-12 embarked onboard the USS Dwight D. Eisenhower (CVN-69) where he was advanced to AO2. In April 1983 he transferred to the Naval Recruit District, St. Louis, Missouri where he was advanced to AO1. In April 1986, he transferred to VA-81, embarked onboard the USS Saratoga (CV-60) where he was advanced to Chief Petty Officer. In September of 1988, he transferred to VFA-87 embarked onboard the USS Theodore Roosevelt (CVN-71). In June of 1990, he transferred to the Strike Fighter Wing Atlantic, Oceana, Virginia. In October 1993 he was commissioned to CWO2. He then transferred to VFA-136



embarked onboard the USS George Washington (CVN-73). In February 1997, he transferred to the Naval Strike Aircraft Test Squadron, Naval Air Station, Patuxent River.

Bud Clark graciously agreed to continue serving as our Chapter President and was elected for another one year term. Also, Walter Gould was elected to the Chapter Board of Directors. He replaced Rod McDonald who faithfully served for five consecutive years. Wanda and Water Gould coordinated a Christmas potluck dinner in December at the Fleet Reserve. The attendance was very good and the food was great tasting. Wanda made beautiful Christmas tree table arrangements. Bob Underwood conducted the drawing for door prizes, and everyone who attended had a good time.

You may recall that Chapter 22 sponsored Ashely Laigle, a local weightlifting champion, presenting her with an Association patch and \$100.00 to help with her expenses. Ashely, a Saint Mary's Ryken High School student, is the daughter of a former service member who was killed in a tragic accident, and the grand daughter of a Navy Chief Warrant Officer (Ret) recently deceased. Ashely won in three "National" weightlifting categories then went on to participate in her first World Power lifting Federation (WPF) meet last month in Las Vegas where she won the gold. At age sixteen her championship results were: Squats 181 pounds, Bench Press 104 pounds, and Dead Lift of 214 pounds. The World meet was represented by five countries and 91 entries. A tape of the event is scheduled for airing on ESPN in the June time frame.

In January AO2 (AW) Russell L. Zachary from Naval Strike Aircraft Test Squadron Weapons Department, was selected as the AO of the Quarter for the fourth quarter 1999. The President of Chapter 22 formally presented AO2 Zachary with a letter, an engraved plaque, and a \$50.00 savings bond. A copy of the recognition letter was sent to AO2 Zachary's Commanding Officer.

Chapter 22 is supporting a recommendation by Chapter member Durwood Wiley to name a ship in honor of John Finn. Our Chapter has formed a committee to spearhead the ship-naming initiative. The committee is devoted to this effort and has started preliminary research into the ship naming process. Additionally, the committee has collected some initial information about John Finn. To our knowledge no other Chapter or organization is currently pursuing this effort. The names of new ships are personally decided by the Secretary of the Navy. Each year the Naval Historical Center compiles ship name recommendations and forwards these to the Chief of Naval Operations. These recommendations are the result of research into the history of the Navy and suggestions submitted by service members and Navy veterans. The Chief of Naval Operations signs the memorandum recommending names for the current year's building program and sends it to the Secretary of the Navy. The Secretary considers these nominations along with others he receives and selects names for specific ships. The Secretary of the Navy relies on many sources to help him reach his decisions. Our Chapter committee coordinating the initiative to name a ship in

honor of John Finn, will spearhead and solicit maximum support from active duty, retired military, civilians, as well as politicians for endorsement. Our committee is reviewing plans with the intent to circulate petitions, and hope all Association members join-in to support our efforts. Chapter 22 has sent a formal letter of notification to the Association, and looks forward to a favorable endorsement. We are open to any suggestions or help.

to display their goods and the room can be secured each night.

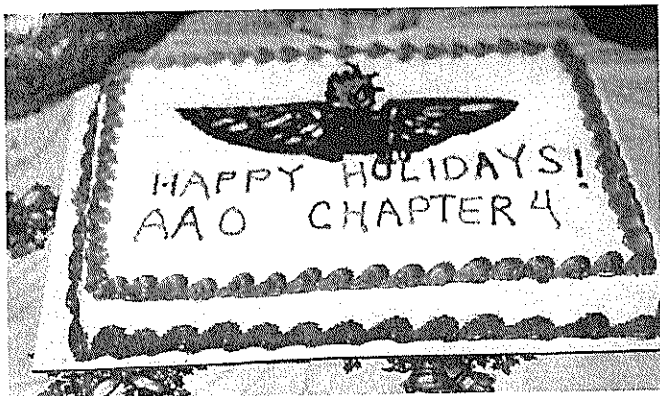


## Tidewater Chapter Chapter IV

## AVIATION ORDNANCEMEN HALL OF FAME AWARD GUIDELINES

1. **PURPOSE:** To establish criteria for nominating individual (s) for the Association of Aviation Ordnancemen Hall of Fame.
2. **BACKGROUND;** The Association of Aviation Ordnancemen is a professional organization, composed of active/ retire/ reserve United States Navy/ Marine Corps and the entire Department of Defense personnel dedicated to promote professionalism and safety of the Aviation Ordnance Field and the Aviation Ordnance Rating. Also, provides technical and professional support whenever possible to the ordnancemen of the fleet. The award was started in 1988 during the annual convention and the original 21 members were the first inductees. The award (s) will be presented to individual (s) who have made outstanding contributions, or demonstrated performance with special recognition in the Aviation Ordnance Field or Association of Aviation Ordnancemen.
3. **AWARD:** The award (s) will be presented during the annual Association of Aviation Ordnancemen's National Convention/ Symposium.
  - a. A certificate signed by the Association President will be presented to the individual (s).
  - b. A plaque, appropriately inscribed with awardee (s) name will be displayed at the John W. Finn Aviation Ordnancemen Museum.
  - c. Awardee (s) will be appropriately recognized at the annual awards dinner, through Naval messages, AO Web site and the Association of Aviation Ordnancemen "RED SHIRT".
4. **ELIGIBILITY;** All individuals who are serving or have served in the Aviation Ordnance field or Department of Defense personnel.
5. **NOMINATION CRITERIA;**
  - a. Nominated individual (s) must be serving or have served in the Aviation Ordnance Rating/ Field and Department of Defense, but need not be a member of the Association of Aviation Ordnancemen.
  - b. Nominated individual (s) must have made a specific contribution through a special achievement or superior performance which has enhanced the reputation, readiness or future well-being of the Aviation Ordnance Rating/ Field and/or the ASSOCIATION of AVIATION ORDNANCEMEN.
6. **SELECTION COMMITTEE;** The selection committee will consist of the Committee Chairman ( Appointed by the President and approved by the Board of Directors) and a minimum of 4 committee members. The selection committee members will be at the discretion of the Committee Chairman. The Committee Chairmen and the Committee members must be members in good standing with the Association of Aviation Ordnancemen.
7. **ACTION;** The Association of Aviation Ordnancemen will solicit nominations through the annual Convention/ Symposium message, AO Web site and through the Association Newsletter, "RED SHIRT".
  - a. Nomination (s) must be submitted to the Association National Secretary/ Treasurer, no later than the first day of the month/ year, the Association Convention/ Symposium is scheduled for.

## By Law Change Recommendations

Presented here are the proposed By-Laws changes that will be voted on at this year's convention. They are being presented as three different and distinct change packages and it is planned that they will be voted on in the same way. You will note that each package is a stand alone package and once voting is completed they will be meshed together by the By-Laws Committee. The first package contains those changes that are of an administrative nature. The second package contains those changes that deal with the proposal for splitting the office of Secretary/Treasurer. The third and last package contains those changes that deal with the proposal for absentee voting.

### PACKAGE ONE

Change the existing By-Laws to read:

#### ARTICLE VI DUTIES OF OFFICERS

##### Section 3.

The Secretary/Treasurer shall keep accurate records of the proceedings of all general business meetings and the meetings of the Board of Directors. The Secretary/Treasurer shall be prepared to refer to minutes of previous meetings, prepare a summary of all unfinished business for the President, and conduct all the necessary correspondence of The Association. The Treasurer shall receive all monies for The Association and shall deposit them in the name of The Association, in bank accounts (savings/checking) approved by the Board of Directors. The Treasurer will submit, for Board of Directors approval, an annual budget. The Associations fiscal year ends May 31st. The new budget will include expenditures authorized during the convention. The Treasurer shall pay out sums as authorized by the Board of Directors. The Treasurer shall submit the financial records of The Association to the designated accounting firm for preparation of a Statement of Accounts in time for the Statement of Accounts to be completed and presented at the general business meeting. A copy of the Statement of Accounts, signed by the accounting firm, shall be available for review by the general membership at the annual meeting. Candidates for the Office of Treasurer shall undergo a background investigation conducted by the Nominating Committee to determine suitability, fiscal responsibility, and satisfactory background to meet standard bonding criteria. The certification of candidates by the Nominating Committee shall satisfy any bonding requirement.

#### ARTICLE VII MEETINGS

##### Section 1.

General meetings of The Association shall be held at a time and location decided by the Board of Directors, as recommended by the convention/symposium committee. The Board of Directors will select a suitable convention site at least two years before the convention. The Board will announce the selected site before or during the general business meeting one year before the subject convention.

## ARTICLE X      AUXILIARY

### Section 1.

The Association of Aviation Ordnancemen authorizes an Auxiliary, known as The Auxiliary to the Association of Aviation Ordnancemen (AAAO).

### Section 2.

The Auxiliary shall conform to the By-Laws of the Association.

## PACKAGE TWO

The splitting of the office of Secretary/Treasurer has been deemed necessary due to the large work load encountered by having only one person do the job. Currently the Secretary/Treasurer expends an average of 30 hours a week doing the job.

If approved, it is planned that an individual for the new office of Secretary will be elected at the convention in the year 2001. The current Secretary/Treasurer will continue on in the new office of Treasurer until the office is up for election at the convention in the year 2002. It is believed that this will provide for an orderly turnover of responsibilities.

Change the existing By-Laws to read:

## ARTICLE V      OFFICERS AND THEIR ELECTION

### Section 1.

The Officers of The Association shall be President, Vice-President, Secretary, Treasurer, Chaplain and Board of Directors.

### Section 6.

The Secretary shall serve for three years, the initial term will expire in 2004.

Section 7. (add a new Section 7 and renumber remaining Sections accordingly)

The Treasurer shall serve for three years, the initial term will expire in 2002.

## ARTICLE VI      DUTIES OF OFFICERS

### Section 3.

The Secretary shall keep accurate records of the proceedings of all general business meetings and the meetings of the Board of Directors. The Secretary shall be prepared to refer to minutes of previous meetings, prepare a summary of all unfinished business for the President and conduct all the necessary correspondence of The Association. In addition, the Secretary as Historian shall compile and maintain all historical data of the Association.

Section 4. (add a new Section 4 and renumber remaining Sections accordingly)

The Treasurer shall receive all monies for The Association and shall deposit them in the name of The Association.

tion, in bank accounts (savings/checking) approved by the Board of Directors. The Treasurer will submit, for Board of Directors approval, an annual budget. The certification of candidates by the Nominating Committee shall satisfy any bonding requirement.

#### Section 5.

The Board of Directors shall conduct necessary business between regular business meetings and such other business as may be referred to it by The Association. The Board of Directors will approve an annual budget during the final Board of Directors meeting of the convention/ symposium. It will authorize the **Treasurer** to expend funds as budgeted. Emergency/unbudgeted expenditures exceeding 5 percent of the approved budget will require approval of the Board of Directors. The Board shall create such standing committees as are deemed necessary to support the Charter of The Association. None of the Boards' acts shall conflict with action taken by The Association. It shall present to The Association a complete written report of all action taken in Board of Directors meetings during the year. Funds bequeathed to The Association and not designated for a program, i.e., Scholarship or Museum,

### ARTICLE IX ESTABLISHMENT OF CHAPTERS

#### Section 2.

A copy of the proposed charter, a table of organization, a chapter membership list and the letter of intent shall be submitted to the Board of Directors via the **Secretary** for approval. A majority vote of approval is required from the Board of Directors.

#### Section 5.

The Chapter will, at The Association's general business meeting, report its goals, functions, and progress to the general membership. If no Chapter member can attend The Association's annual general meeting, they shall submit a written report to The Association **Secretary**, to be read by him at the general business meeting.

## Section 8.

If a Chapter remains inactive for one year, the Chapter will receive a letter from the Secretary, with copies to the President, Vice-President, and Board of Directors, warning said Chapter of its inactivity and giving ninety (90) days to take appropriate corrective action to get the Chapter functioning properly. Inactivity includes failure to submit all reports, minutes and transactions/information deemed necessary by The Association and failure to conduct bi-monthly meetings. The Chapter will be required to submit a written report to the Secretary on appropriate action taken to correct deficiencies. If no appropriate action has been taken at the end of this ninety (90) day period, the President, Vice-President and the Board of Directors will take action to disestablish that Chapter. Upon approval from the Board of Directors, the Secretary will give that Chapter written notification of its disestablishment. That Chapter may resubmit a request after one (1) year to reestablish, provided all requirements outlined in The Association By-Laws are met. The exception to this rule will be allowed by aircraft carriers established as a chapter during overhaul periods. The chapter will be required to submit a letter of intent to down size during this period of overhaul to include a proposed conclusion date. For administrative purposes, the one year inactivity starts, once the overhaul period ends for disestablishment proceedings.

## PACKAGE THREE

The proposal for absentee voting was submitted to allow those who are unable to attend the convention a chance to make their voice heard.

Included at the end of this package are the Procedures for Absentee Voting which have been agreed upon by your elected officers. These procedures are being presented here to give you a better understanding of how things will work. The procedures are part of Appendix A thus giving your officers the ability to change them as necessary to keep the Association running. As a part of Appendix A they are not voted on or approved by the general membership.

Change the existing By-Laws to read:

## ARTICLE V      OFFICERS AND THEIR ELECTION

### Section 9. (renumber as Section 10.)

The election of officers shall be held by balloting at the annual general business meeting. Officers will be elected by plurality vote. If there is but one candidate for any office, the ballot for the office may be dispensed with and the election held by voice. Absentee voting procedures will be provided for the election of officers.

### Section 10. (renumber as Section 11. and renumber remaining Sections accordingly)

Nominations for officers shall be made to the Nominations Chair. The consent of each candidate must be obtained before the name is placed in nomination. To ensure an orderly transition of office, candidates must be present at the annual general business meeting. Absence of a candidate from the general business meeting requires the approval of the Board of Directors. To qualify for absentee ballot, nominations must be received by the Nominations Chair on or before the date set by the Board of Directors at its annual meeting. This date must be met to qualify for vote by mail. The date will be published in the newsletter issue that immediately follows the convention/symposium and subsequent issues. Additional nominations may be made from the floor during the general business meeting.

## ARTICLE XI AMENDMENTS

### Section 2.

These By-Laws may be amended by a two-thirds (2/3) vote of the attending voting members at the annual business meeting **and verified eligible absentee ballots. Notice of intent to change must be given in time to be put on the absentee ballot and the intent to change must be published as an agenda item prior to being voted on.**

### **Procedures for Absentee Voting**

1. Nominations for officers shall be made to the Nominations Chair on or before the date set by the Board of Directors at its annual meeting. This date must be met to qualify for vote by mail. The date will be published in the newsletter issue that immediately follows the convention/symposium and subsequent issues. The nominations must be accompanied by the following:

- \* A brief biography of the nominee or synopsis of why the nominee is a worthy candidate.
- \* Acceptance of nomination by the nominee and acknowledgment of the requirement for the nominee to be present at the general business meeting.
- \* Photograph if available.

2. Nominations Chair will verify the eligibility of nominee and nominator with the Treasurer.
3. A nomination for Board of Directors will be considered for all Board of Directors positions available for election in that year if nominee is not elected to the first position available.
4. Nominations Chair will prepare the ballot and forward it to the Newsletter Editor.
5. Ballot will be published in the last newsletter prior to the annual general business meeting for the election that year.
6. Member must clearly identify the nominee of their choice when voting for the election of officers. On approval of changes to the By-Laws, or other issues on the ballot, the member will indicate whether "For", "Against", or "Abstaining".
7. Member will place ballot in sealed envelope with their printed name, membership number and signature on the outside of the envelope. The envelope, with ballot, will be delivered to the Nominations Chair in one of the following ways:

- \* By U. S. Mail, to be received by the Chair on or before the due date presented on the ballot.
- \* Hand delivered, to be received by the Chair NLT 24 hours prior to the published start of the general business meeting.

Ballots received in any other manner will not be accepted.

8. Head Teller will verify, with the Treasurer, the voting eligibility of the member before the start of the general business meeting. The Teller will also verify the eligibility of voting members present.
  9. Absentee ballots will remain sealed in the possession of the Head Teller until such time as the balloting of the members present at the general business meeting begins. At this time the Head Teller will open the envelope, remove the ballot and give it to a teller for counting.
  10. Any member who attends the General Business Meeting who had previously submitted an absentee ballot shall have said ballot invalidated.
