Rear Admiral Robert Sutton entered the U.S. Naval Academy from Coral Gables, FL, and was commissioned upon graduation in 1964. His initial assignment was as Damage Control Assistant on USS McCAFFERY (DD 860) followed by an 'in country' tour as a Naval Advisor to Vietnamese Navy Coastal Group for one year.

Lieutenant Junior Grade Sutton then served as Executive Officer of USS PINNACLE (MSO 462) from 1968-1970. An assignment to the U.S. Naval Postgraduate School followed

with Lieutenant Sutton earning an M.S. degree in Operations Research in March 1972. A two-year tour as Weapons Officer in USS WAINWRIGHT (CG 28) followed prior to assignment in the TERRIER/TALOS Department of the Naval Ships Weapons Systems Engineering Station, Port Hueneme, CA, from 1975-1977.

Lieutenant Commander Sutton served as Executive Officer of USS MITSCHER (DDG 35) and subsequently USS CORONADO (LPD 11) during the period 1977-1979. A tour in the Naval Sea Systems Command, Long Range Missile Systems Division for two years preceded his assuming command of USS PREBLE (DDG 46). During Commander Sutton's tour from August 1982 to November 1984, PREBLE deployed to South America and the Indian Ocean and won the ARLEIGH BURKE award for improvement in combat readiness.

Captain Sutton then served in the Office of the Chief of Naval Operations as Head, Anti-Air Warfare Branch, Surface Combat Systems Division in 1985-1986 prior to assuming duties as Commanding Officer Pre-Commissioning Unit THOMAS S. GATES (CG 51), in September 1968. After commissioning in August 1987, GATES completed her workups and deployed to the Mediterranean and the Black Sea, where she conducted an historic port visit to Sevastopol, USSR, in August 1989.

Upon completion of his tour in USS THOMAS S. GATES (CG 51), Captain Sutton assumed duties in September 1989 as Director, Fleet Introduction and Lifetime Support Division of the AEGIS Shipbuilding Program (PMS 400). Captain Sutton was selected for Rear Admiral in December 1989. He assumed duties as Commander, U.S. Naval Forces Central Command, Pearl Harbor, HI, in June 1990. In August 1990, he was forward deployed as Commander, U.S. Naval Logistics and Support Force (COMUSNAVLOGSUPFOR) in Bahrain in support of Operations Desert Shield and Desert Storm, Upon disestablishment of COMUSNAVLOGSUPFOR in April 1991, Rear Admiral Sutton, in a Navy component command restructuring, was designated as Commander, U.S. Naval Forces Central Command Rear. In September 1991, he was assigned as Commander, Training Command, U.S. Atlantic Fleet. Rear Admiral Sutton assumed duties of Commander, Naval Ordnance Center in October 1993.

Rear Admiral Sutton's awards include the Legion of Merit (four awards), the Bronze Star with Combat "V", the Meritorious Service Medal (two awards), the Combat Action Ribbon, the Navy Commendation Medal and the Medal of Bahrain, Degree One.

Rear Admiral Sutton has two children, Laney and Bob.

1994 CONVENTION REPORT

The Hotel is set, the registration room has been assigned, committee rooms have been assigned, agenda is prepared, now all we need is YOU AND YOUR GUESTS. I Just checked with the hotel and I don't see that you have filled the rooms that we blocked for you. ORDIES WHERE ARE YOU??? If you haven't made your reservation yet (and most of you have not) please ensure that you do make them by the 24 of May 1994. After that date the Hotel will no longer keep our block reserved. Also, if you plan on coming early and staying later, the hotel will book you at The Association's rates, but you must make your reservations <u>NLT 24 May</u> 1994.

Despite what you hear, we in the Midwest are in no danger of being swept away by flood waters. We are currently experiencing our normal, above normal, spring rains, but unless we have a repeat of last year there should be no problem with flooding. Just because the Missouri and Mississippi rivers run through or border Missouri every part of Missouri is <u>not</u> impacted by heavy rains. Heavy rain here normally has about as much effect on us as the effect of heavy waves on the Pacific coast has to Death Valley.

I have to say that I am disappointed to hear, via the rumor mill that a lot of you from the West Coast are not planning on attending this year. It is with regret that I must report to you that the state of Missouri did not pass the gambling referendum during the recent election. However, there is still Riverboat gambling evailable on the Illinois side of the Mississippi River.

Your convention committee is holding meetings to decide upon what type of tours to set up, what type of entertainment, menu, and all the logistical problems that are involved with setting up a convention to ensure that you enjoy yourself. Hiring regular motor coaches (Grey Hound type) is cost prohibited.

For those that are still pursuing our livelihoods in the ordnance field, seldom does a day go by that you don't hear of at least one incident, no matter how minor, somewhere in the world. I don't have accurate facts and figures in front of me, but I'd be willing to bet that at least 90% of those incidents are caused by one or more of the reasons listed above. No matter how you look at it, its always going to spell HUMAN ERROR.

As Aviation Ordnancemen, we have many responsibilities, one of which is to ensure all ordnance evolutions are conducted safely. Now that is a very general statement that can mean a whole lot of things. But as an ordnanceman, the first thing that should come to mind when your are thinking about ordnance safety is training. If you are a worker bee, are you sure you are familiar with ALL the safety precautions related to the task at hand? If not, ask your crew leader or supervisor. There are other ways too. Remember the old adage, "If you want a new idea, read an old book". Open those books that are just laying around in the shop. You might be surprised at what you may learn.

If you are a supervisor, are all of your people properly trained and qualified to do the job: If not, its your responsibility to ensure they are. You must also practice what you preach. Lead by example. If the junior people see yo do something not quite by the book, they may think its OK and make it an everyday occurrence.

Once your people have received all the necessary training, ensure it is put to good use. People do get tired and complacent. When they do, they get careless. Combine that with over confidence and an over familiarity with dangerous ordnance and you could a have a fatal situation. Don't let it happen. If a gentle reminder doesn't work, then try a swift kick in the butt, just don't let it happen. Remember, what we do is by its very nature, inherently dangerous. Its the job we've chosen, so let's do it and DO IT SAFELY!

Anyway, he finally left the court to preach (his specialty) in Cilicia and along the coast. He was particularly concerned with the welfare of sailors (Taa Daaaal!) and is considered the patron of Spanish and Portuguese sailors along with St. Elmo (he was covered a few issues back). He died at Tuy, Spain. His feast, or day of special honor is April 14.
