Have you had a promotion, change of status (recently retired) or phone number change? If so give me a shout at the contact info below so I can update your record.



AMRAAM

Cmdr. Arch "Gorch" Watkins and Lt. Cmdr. Jeff "Stoli" Stodola of VAQ-209 successfully employed an AIM-120B AMRAAM off the coast of Virginia, as part of a multi-plane multi-missile Tactical Support Wing training event, Sept. 1. This marked the first time in squadron history that the Star Warriors employed an air-to-air missile. This was also a career first for both aviators on board.

The small cadre of maintainers, led by CWO4 Michael Pendleton, made the trip to NAS Oceana having just returned a week prior from Red Flag Alaska, the first large-force exercise the squadron had participated in since receiving safe-for-flight certification in the EA-18 Growler a little more than a year ago.

In the next two weeks, VAQ-209 will also live fire an AGM-88 HARM off the coast of Point Mugu. These events reflect the radical increase in capability the EA-18G brings to the Fleet, including the ability to take on a host of mission sets in both the air-to-air and air-to-ground battlespace arenas.


