



As I sit here at O'-Dark-thirty (actually 0255) on a Tuesday morning, I have finally come to the realization that my sleep schedule is all hosed up. To be awake in the watches of the night is not fun. It does, however, give one time to think and remember and reflect. I was just thinking of my last days as a member of the Navy's VA-155 Light Attack Squadron, the Silver Foxes. I am Don Shirley, now an almost seventy-six year-old retired sailor who back then, as a Chief Aviation Ordnanceman, was scheduled to transfer from VA-155 to Instructor Duty at the Naval Air Maintenance Training Detachment (NAMTRADET) at Naval Air Station (NAS) Lemoore, Ca. before the USS Ranger's 1968 combat cruise to the Western Pacific (read Vietnam) from NAS Alameda at San Francisco began. The Bureau of Naval Personnel ( BU-PERS), however came out with a new policy that stated that if the next cruise started less than three months from when your orders went into effect, they could take you out with them. Guess who got to go to sea on Ranger? When my relief, AOCS (Senior Chief Aviation Ordnanceman) Art Patch came aboard, I went to the Night Maintenance Chief job.

About six months into the cruise, they finally relented and during an in-port period at Subic Bay Naval Station in the Philippines, they let me go home, and I had a traveling companion, too. Aviation Ordnanceman Second Class (AO2) Pat Wallace, one of my best troops and an integral part of my bomb loading crews had completed his enlistment and was due to get out of the Navy. Most of the rest of my crew also served their time, took a well-earned Honorable Discharge, and returned to civilian life to carve out careers for themselves and their families. I like to think that when all of those guys went back home, they took some things with them that they had learned during endless days of toiling on a steaming flight deck, working sometimes around the clock in one of the most dangerous working environments in the world; an aircraft carrier flight deck during flight operations. I am quite sure that they learned that hard work will not kill you but inattention most certainly will, and that learning to work together as a part of a team is one of the most important things one can do in order to be successful in life. That's enough of the philosophy.

AO2 Wallace was known in the Squadron as "Wally". Sometimes your name as used by your peers in the service is some sort of a bastardization of your real name; some times it just is your real name; and sometimes it is just a name made up on the spot. I once knew a fat kid in a previous Squadron who walked kind of funny, and one day someone made the remark that AO3 Richards didn't really walk, he just kind of "ooshed" along. From that day forward, he was "Ooshy" Richards. I think he kind of got to liking it. Wally was a great kid and I was glad to have him travelling

with me. He came from the little town of Mena, Arkansas, and he would regale us with his tales of the country lifestyle, most of it made up of course (but I was never quite sure about the stump-broke cow story). Anyway, when we got to Clark Air Force Base for our flight home, the bird was down, and we had to wait until the next day to leave. We went out the Clark Field Main Gate to Angelese City, got a motel room for the night, and did a little pub crawling. Remind me some day, and I will write you a dissertation on the differences in the bar scenes between Subic Bay's Olongapo City (or simply, "The PO" as it came to be called) and Angelese City at Clark. Then it was back to the room for a good night's sleep.

The next day, we were off on an uneventful trip aboard a Military Airlift Command (MAC, or as they are more commonly known, Screaming Baby Airlines) 747 aircraft. They are called that because of the number of young dependents with young children that they transport, usually un accompanied by their military spouses. The 747 aircrew must have been really leaning on the throttles, because we landed Northeast of San Francisco at Travis AFB, the West Coast MAC hub only about five hours late from our original arrival time. My wife Lisa was there waiting for me, having left NAS Lemoore in California's Central Valley about midnight for the long drive to Travis. We threw my gear in the car and then Wally's bags, and I said we would take him over to the Shuttle Bus stop for busses going to the San Francisco Airport where he was to catch his flight home. But NO, the wife is not hearing any of this. Why should Wally have to wait to catch, and then get on and ride that nasty old bus down the Golden Gate, the peninsula, across downtown San Francisco traffic, way out past Candlestick Park to SFO, when we could do the same thing, never mind the almost two hours extra driving time and the over one hundred road miles out of our way? And, there would be no more discussion on the subject. I'm pissed, she is pisseder (if there is such a word), and Wally is becoming damned uncomfortable.

We climb in the car, and I hit the ignition switch and "CLICK".... Nothing, "CLICK"... "CLICK"...Nothing, Lisa had left Lemoore around midnight and arrived at Travis well after daylight, never thinking about turning off the car's headlights. The result was a dead battery from the car setting in a parking lot for about six hours, lights blazing. I couldn't blame her, however, I have done the same thing myself. Well, there was nothing to be done except to make a bad situation better, so I got on the phone to the Base Gas Station/Garage and asked for someone to come out and provide my dead battery with a jump so that we might be on our way. "No problem", he says, and after about ten minutes a young man driving a bob-tailed tow-truck showed up. The young man popped the hood on my 1967 Ford Fairlane, and (Continued on page 17)

starts to hook-up his cabling, telling me to be ready to "Hit it when I give you the word". I don't know what he had hooked up to what, but all of a sudden, a boiling reddish-white cloud of smoke started rising along with this weird crackling noise as all of the wiring in my engine compartment fried and all of the major components of my ignition system melted . I am so mad I can't think straight, the kid is shaking like a leaf, Lisa is crying, and Wally just really, really wants to go home. I get back on the phone to the Garage Management, and they are profusely apologetic, and say they will do everything they can to help us through our ordeal. And they did.

They towed our car back to the Garage after dropping Wally off at the Bus Stop (never to be seen or heard from again), and installed Lisa and I in a nice room in the "Billets", which I gather is Air Force lingo for the Navy equivalent of a Transient Barracks. There was even a quiet little bar at the end of the building. I have often teased my USAF Retired (23 years)

son that while the Air Force may lack somewhat in the "HUP TOOP TREEP" or the "OOOHRRRAAA" departments, they do take care of their troops on a day-to-day basis. They gave us chits for Lunch, Dinner and the Breakfast meals the next day in the base Cafeteria. About ten o'clock the next day, our car was ready to go. They had worked through the night, replacing the battery, the alternator, starter, distributer and all associated wiring and bulbs, as well as loading us up with a full tank of gas. The car never ran better. The Manager told me he would like to fire the kid who caused the problem but his dad was some big base Master Sergeant or something. We got home later that day, tired but happy. Luckily for us, my oldest daughter Julie was thirteen and a very mature young lady fully capable of handling her younger siblings for one more night than planned on.

Ya'll have a great Navy day now, ya hear?




