Please remember all our brothers and sisters in arms, where ever they might be. Pray for their protection and a safe speedy return to their home and loved ones.





Happy Birthday John Finn

John William Finn was born on 23 July 1909 and enlisted in the navy in 1926, and became an Aviation Ordnanceman and worked his way though the enlisted ranks, being promoted to Chief Petty Officer in only nine years.

In 1941, John Finn was stationed in Kaneohe Bay, Hawaii with VP-41.

On the morning of 7 December 1941, when the Japanese attacked Pearl Harbor, he manned a.50 caliber machine gun mounted in an exposed ramp area. He fired upon the enemy and reports indicated he single-handedly shot down one Japanese aircraft killing the pilot.

John was under heavy enemy machine gun fire and he was severely wounded, sustained approximately 21 wound marks throughout his body, including shrapnel in his chest and abdomen.

Nine months later, Admiral Chester Nimitz awarded Aviation Ordnanceman Chief Petty Officer John Finn the Medal of Honor, our nation's highest award while on board USS Enterprise. John's citation was signed by President Franklin D. Roosevelt. Admiral Halsey who was on board the Enterprise, quoted as saying "Finn's magnificent courage in the face of almost certain death helped repel the Japanese attack. His complete disregard for his own life, in staying with his machine gun, although many times wounded, is the kind of American fighting spirit necessary to victory."

Today is John W. Finn's 100th birthday.

Finn is the oldest living Medal of Honor recipient and is also the only living Pearl-Harbor-Day Medal of Honor recipient.

Finn is the last surviving Medal of Honor recipient from the attack on Pearl Harbor, as well as being the oldest living recipient. John Finn is the only Aviation Ordnanceman Medal of Honor recipient in the history of the rate. In addition to all of this, Finn's Medal of Honor is the only medal of its kind with a citation on the back summarizing the events of heroism.

To tell his story, his manner and style of speaking gives a hint to why that WW2 generation is the greatest generation this nation has ever seen.

Happy 100th Birthday to John W. Finn, a Great American Hero.

Pearl Harbor Hero Is 100 Years Old Today (RAMONA SENTINEL (AZ) 23 JUL 09) ... Harold J. Schachter

This edition of the Ramona Sentinel is dated the same day that Medal of Honor recipient John William Finn turns 100. Some of you reading this will recognize who John Finn is. I suspect, however, that most of you will not.

John William Finn is our nation's oldest living recipient of its highest award for valor, the Medal of Honor (MoH). He is also the last surviving MoH recipient who earned his medal on Dec. 7, 1941, the last living recipient of the Navy's MoH from World War II, and the only MoH recipient having his Navy rating, that of an Aviation Ordnanceman, to ever be awarded the MoH in the history of the United States Navy.

John William Finn was born in Los Angeles on July 23, 1909. In July of 1926, as soon as John turned 17, he enlisted in the Navy. When, on Sunday morning, Dec. 7, 1941, the Japanese attacked Hawaii, then a U.S. Territory, John was 32 years old and had attained the rank of Chief Petty Officer (CPO), then the highest enlisted non-commissioned officer rank in the naval service.

John was stationed at Naval Air Station Kaneohe Bay, about 15 miles east-northeast of Pearl Harbor, on Oahu's south-eastern shore. Chief Finn had recognized the air station's vulnerability to possible air attack and had strongly recommended to his superiors that they take measures to establish anti-aircraft defenses to protect the naval base from possible attack, but his urgings, for whatever reasons, were ignored. So, when the attack came on that first Sunday morning in December, Chief Finn single-handedly mounted a 50-caliber machine gun on a stand on the base's aircraft parking ramp and began firing on any attacking enemy aircraft that he could bear on.

John's position was totally exposed to enemy strafing and bombing attacks, but he kept it up for more than two hours while under attack, despite being wounded five times and in severe pain. Fellow sailors implored him to seek medical care for his wounds, but John steadfastly refused to vacate his firing position until he received a direct order to do so from a superior officer.

Twenty pieces of shrapnel were removed from John's body by the base's medical staff.

John has remarked that, while he was scared, being exposed like that, he "was so damn mad" that what he feared might happen was now happening and that all his warnings and urgings had been in vain. He's said that his anger overruled his fear and he kept on shooting.

John's actions that Dec. 7th morning were briefly depicted by an unnamed and uncredited actor in the 1970 epic motion picture, Tora! Tora! Tora!

On Sept. 15, 1942, CPO John William Finn received his Medal of Honor, the first one to be awarded in World War II. It was presented to him by Admiral Chester W. Nimitz in a ceremony aboard the Big "E," the aircraft carrier USS Enterprise (CV-6).

Some 27 months later, on Dec. 19, 1944, Adm. Nimitz would receive a fifth star designating him a Fleet Admiral (FADM). Nimitz would become the last surviving FADM of the four FADMs who were appointed, when he died on Feb. 20, 1966.

And here he was, awarding the MoH to someone who would become the oldest surviving MoH recipient in our nation.

John was to subsequently gain "Mustang" status on becoming a commissioned officer and he would retire from the Navy in September of 1956 with the naval rank of lieutenant, having faithfully served our country as a sailor for more than 30 years.

The group of living MoH recipients that John Finn is the eldest member of is becoming ever smaller and more "exclusive." Why? Two reasons mainly.

There have been far fewer awards of the medal since the withdrawal of U.S. forces from Vietnam in 1973 and, of the seven MoH awards that have been earned since then, all of them have been made posthumously.

Prior to the above stated time, and reckoned from the beginning of WWII, 61.09 percent were awarded posthumously. In combat actions since then, 100 percent have been posthumous awards.

And during the above stated period, the award of the MoH, based on the number of U.S. forces serving in a combative conflict, was 10 times what it's been since then.

As evidence of the shrinking size of living MoH recipients, here are some snapshot samplings:

In 1996, there were 171 living recipients.

In 2002, there were 103 living recipients.

Today, there are 96 still living.

So, the membership of living recipients hasn't gained even one member for any of the country's combat actions that have taken place in more than the 35 years.

On Saturday, June 27, 2009, with slightly less than a month to go to his 100th birthday, John Finn was celebrated and honored at a ceremony held at the La Posta Café on Old Highway 80, just east of his home in Pine Valley. Among the many honors paid to John that day was the dedication of a monument and plaque presented by the John P. Squibob Chapter 1853 of the Ancient and Honorable Order of E Clampus Vitus (ECV), the same organization that had presented a plaque to Ramona Town Hall on Saturday, April 25, 2009.

The chapter's Grand Noble Humbug, Paul Ketchem, a Ramonan, officiated at the monument's dedication to Finn. According to Ketchem, including wives and children, there were several dozen of Ramona clampers among some 200 ECV'ers who turned out for the event. And there were others from Ramona who were there who were not connected with the ECV. Julie Lamkin was there with her two children, James, 5, and Rose, 3.

When the day dawns on July 23, John Finn should be experiencing his birthday as a guest of former President George W. Bush and former First Lady Laura Bush. John has been invited to celebrate his becoming a centenarian at the Bushes' ranch in Crawford, Texas.

Here's wishing you, John, many happy returns of the day. And maybe, just maybe, a few more of your fellow Americans who've read this will know who John William Finn is and what he's done.

Thank you, John Finn.

PINE VALLEY, California (CNN) -- Dozens of America's greatest military heroes are gathered in Chicago, Illinois, possibly the last large gathering of living Medal of Honor recipients. Among the men with light blue ribbons holding a star around their necks signifying uncommon bravery, will be John Finn.

Finn, who received the nation's highest medal for valor for his actions during the Japanese attack on Pearl Harbor, turned 100 this summer, the oldest living Medal of Honor recipient.

Finn was stationed at Kanoehe Bay Naval Air Station, where the Japanese struck five minutes before attacking Pearl Harbor, across southeast Oahu Island from Kanoehe Bay.

Finn recalled how a neighbor was the first to alert him, when she knocked on his door saying, "They want you down at the squadron right away!"

Finn saw the first Japanese plane before his car even reached his hangar. "I put that old car of mine in second gear and wound it up getting down to the hangar where I could be where my guns and ammunition were," Finn said. One of the first things he did was take control of a machine gun from his squadron's painter. "I said, 'Alex, let me take that gun,' "Finn explained. "I knew that I had more experience firing a machine gun than a painter." "I got that gun and I started shooting at Jap planes," Finn said in the salty language not uncommon among veterans of that long-ago war. But Finn's machine gun was right out in the open, nothing protecting him from the attacking pilots. "I was out there shooting the Jap planes and just every so often I was a target for some," Finn said. "They were Japanese fighter plane pilots. I can remember seeing, in some cases, I could see their faces. He was wounded in the head, the arm, the hand and the foot, but Finn fought on, a one-man counterattack to the surprise air raid that pulled America into World War II. The Medal's History

Finn talked to CNN at his ranch in the desert east of San Diego, California. He surrounds himself with reminders of his life -- his entire life, not just that one infamous day out of 100 years. There are pictures of his wife, Alice, who married him before Pearl Harbor and was by his side until 1998. The hillside outside his home is covered with old cars, old trucks and even an old military ambulance. But the first thing one notices when visiting Finn's ranch is the sign at the road, with a painting of his medal next to his name.

The citation for his Medal of Honor tells that part of his story: "He continued to man this gun and to return the enemy's fire vigorously and with telling effect throughout the enemy strafing and bombing attacks and with complete disregard for his own personal safety. It was only by specific orders that he was persuaded to leave his post to seek medical attention. Following first-aid treatment, although obviously suffering much pain and moving with great difficulty, he returned to the squadron area and actively supervised the rearming of returning planes," the citation stated. With Japanese still attacking, getting his wounds treated wasn't a priority, Finn said. "Medical help comes later. If you're busy shooting a machine gun or a rifle or a pistol or doing anything, you can't worry about getting medical attention," he explained.

Less than a year later, Finn, out of the hospital and recovered from his wounds, was back on duty with the Navy in

Hawaii. Adm. Chester Nimitz presented Finn with the Medal of Honor for his bravery, joining the ranks of the men, and one woman, recognized with the nation's highest award for heroism.

These days most medals are awarded at the White House, but with the war heating up, such a long trip was out of the question. In fact, his first visit to the White House came in the spring when President Obama invited him for a visit.

Back at his ranch, Finn bristled when asked about being called a "hero." "That damned hero stuff is a bunch crap, I guess. Well, it is one thing that I think any man that is in that, you gotta be in that position," Finn said. "You gotta understand that there's all kinds of heroes, but they never get a chance to be in a hero's position."

Fewer than 100 men who have received the Medal of Honor are alive today. More than half of them are expected in Chicago this week for the annual Congressional Medal of Honor Society Convention. But because they are all veterans of World War II, Korea or Vietnam, their ranks are shrinking every year.

The men from more recent conflicts, like Somalia, Afghanistan and Iraq, were all awarded the Medal of Honor posthumously. And this week, while many of those living recipients gather in Chicago, Obama will present the latest Medal of Honor at the White House to a soldier who fought and died heroically in Afghanistan.





To those who are still in the fight, GIVE'EM HELL and GOD BLESS.






FWST Supports AIM-9X Program Office during Reprogramming Effort


The AIM-9X Sidewinder is a "Smart-Weapon" that requires reprogramming to ensure that the latest tactics, countermeasures and improvements are available to the Fleet. Software changes are delivered to the Fleet by Technical Directive (TD) as an Airborne Software Change (ASC). In order to speed the process of TD incorporation and meet deployment cycles, PMA-259 Air-To-Air Weapons requested the assistance of the Fleet Weapons Support Team (FWST) in the reprogramming of AIM-9X Tactical assets at NWS Earle and NWS Indian Island. Reprogramming at Earle and Indian Island posed a special issue, as there is currently no CMBRE support equipment or ASX power supplies on hand. The AIM-9X Program Office forged a combined team of personnel from the CMBRE Program Office and the FWST to travel to both locations, interfacing with the Naval Weapons Stations in the completion of ASC-6 on all stored AIM-9X assets. The team additionally assisted the Program Office by providing support to the Raytheon depot team who was on hand to complete the rocket motor screw/ Control Actuation System AWB-438 inspection for affected assets. During this evolution, cross training was performed between NWS personnel and FWST/CMBRE/Program Office personnel in the performance of Smart Weapons CMBRE reprogramming efforts. The Program Office would like to thank all members of the CMBRE/FWST Team. They were able to provide much needed support in a short turn-time frame to meet deployment cycles. A HUGE Bravo Zulu goes out for the outstanding professional support provided by Nick Cuzzolino and his team at Naval Weapons Stations at Earle New Jersey and Larry Metcalf and his team at Indian Island Washington, Additional thanks goes out to COMNAVAIRLANT for the provision of MHU-191's and ADU-514's in support of this evolution.

IT'S NOT "A" SCHOOL OR AOOCP BUT IT'S A START

I have spent the last year in Baghdad, Iraq on a one year IA. Last issue of the Red Shirt, you were introduced to the Iraqi General's who are responsible for the storage and issue of all ammunition in the Iraqi military. These Iraqi Officer's were experts in ammunition and had over 98 years of experience between them.

Prior to the coalition's ousting of Sadaam Hussein, the Iraqi Army had no training plan of any kind. There were no PQS booklets, no "A" or "C" schools of any kind. There were no Mobile Ordnance Training Teams (MOTT); it was all done by OJT. Iraqi Officers back in the late 1960's through the mid 1980's were educated in the Soviet Union while the enlisted men had no formal training. This was all taking place during the Iran/Iraq War and the fall of the Soviet Union, so training was very limited.

Since the ousting of the former regime in 2003 to present, the United States has had troops on the ground in Iraq. Once the violence was stabilized, the mission of the unit I am assigned to, Multi National Security Transition Command-Iraq (MNSTC-I) in partnership with the Iraqi Government, was to rebuild the military and help establish a de-

mocratic government. As the advisor to Brigadier General Mohammed Ali, Commanding General of Ammunition Command, it was my job to advise on all matters of ammunition management. BG Ali is a very intelligent man who has a vision for how ammunition should be stored and is a strong supporter of training and standardizing ammunition storage at each location within the country.

On his own initiative, BG Ali decided to build a school house at his compound in Baghdad and develop a curriculum, to teach Officers, Warrant Officers and enlisted men assigned to the various storage facilities throughout the country. The primary focus was on weapons handling and safety and the proper procedures for issuing and receiving ammunition. First, we needed to get detailed information on each piece of ordnance in the Iraqi arsenal and spell it out in simple terms for everyone to understand. This was very similar to the AO 3, 2, 1 manual. It was an overview of the various weapons and their function.

Next, we began to focus on the safety aspects of each weapon systems ammunition. Remember that Iraq is not a member of NATO, so they buy ammunition from all over the world from non-NATO countries such as Bulgaria and Serbia. These non-NATO countries are not required to build their ammunition to agreed specifications as NATO countries do, so gathering information and technical data is difficult.

Once that was complete, ammunition storage became the main focus. Iraq has some earth covered barricaded storage facilities but for the most part, large warehouses are what is utilized to store vast amounts of ammunition. There was little-to-no concern for Quantity Distance or compatibilities. Using OP 5 as a basic guide, we developed a Standard Operating Procedure (SOP) for each storage location and a general guide to storage of various types of ammunition from small arms 5.56 M-16 machine gun ammo to 120mm mortars and 120mm tank rounds for the new M1A1 tanks sold to the Iraqi Army by the United States. Lightening Protection and electrical grounding are concepts new to the Iraqi Army. Like any large project, you must build a strong foundation before moving forward. Keeping the SOP's and curriculum simple and basic were a must to keep the mentality of crawl before you walk concept. Storage limitations, ammunition compatibility and emergency procedures are the foundation and inventory accuracy, security and professionalism were the next steps to develop. Taking pride in your work and understanding the duty ammunition handlers have and teaching them the vital responsibility placed upon them is fundamental in rebuilding an army and making this army a team functioning together. Once the curriculum was developed, instructors were hand chosen by BG Ali and a classroom had to be built. BG Ali had no facility funding for this school house so he built this school with his own money. He even had his soldiers build the chairs for the students to sit on. Acquiring a damaged trailer, much like the trailers used by FEMA during the Katrina hurricane and began to turn this small trailer into the first Ammunition School House in the history of the Iraqi Army. With a few

gallons of paint and a dry eraser board, overhead projector and some help from our friends at General Dynamics, who provided posters of various weapons utilized by the Iraqi Army, this trailer transformed into a functional school house.

In 2009, 4 classes will be taught. To date two of the four have completed. Each class is 45 days long and students are tested weekly with a final exam. Upon graduation, the students with the highest marks are allowed to pick their duty station. This is usually a location close to their home and family. This incentive is established on day one and the competition is fierce to be the very best. The classes consist of up to 25 soldiers per class and classes are broken into groups by pay grade. To date, the average test scores of the first two classes is 92%, which in my opinion is off the charts. These men are so eager to learn and have a great leader to motivate them. BG Ali addresses each class at the beginning and spends time discussing devotion to country, duty and honor and the important of the task given to weapons handlers. He speaks of being a true professional by knowing your weapons systems and safety procedures. He stresses leadership-by- example and demands excellence from his officers, warrant officers and soldiers alike. Upon completion of the final exam, BG Ali addresses the class and provided diplomas and announces who had the highest score.


The Ammunition Command has come a long way over the past few years and it has been an honor and privilege to work with and live next to the Iraqi people. This experience has been a life changing experience for me. I was afforded a wonderful opportunity to come to Iraq and assist in the rebuilding of an Army from the ground up. Humbled by the grace and affection of the Iraqi people, I am overwhelmed in the hospitality and friendship they have shared with me. Brigadier General Mohammad Ali and his team of weaponeers are highly motivated and eager to learn and grow as a command. I will miss them all and hope someday to share my home with General Ali. I am excited to get back to them but sad to say good bye to my friends and colleagues in Iraq. As a parting gift I presented General Ali a United States Naval Officer's Sword as a show of respect and admiration and wishes him and his family the very best.

Combined Federal Campaign Committee, Joe Manley -As the Chairman of the CFC I'm happy to report that because we were accepted into the 2008 Combined Federal Campaign that so far the Education Foundation has received as of 08-03-2009 \$14,246.00 in donation to the scholarship fund. The Education Foundation has also received information that obligated funds of \$15,705.00 will be received by March of 2010. This was only possible by members of the Association and non members Ordies generous donation to the Education Foundation. This is indeed a great moment completing many years of effort by few members to finally gain admittance and to have our name listed under "National/International Independent Organizations". Thanks to one and all for your efforts and support! Special THANKS goes out to Dick Grass and Ed Scott for all their help they provided me with information to use in the submission of the Association annual application. As you may have noticed I said annual submission.

This year we were not successful in our application for acceptance to participate in the 2009 Combine Federal Campaign. We were denied because of a deficiency in our Attachment A that requires that our organization provides or conducted real services, benefits, assistance, or program activities in 15 or more different states or a foreign country over the three-year period immediately proceeding January 2009. We appealed their denial and were again turned down for acceptance. Although our application for 2009 mirrored the 2008 application we will be reviewing the requirements again this year and hopefully find a way to meet the requirements of Attachment A. Work has already stated on finding the right elements to put in Attachment A to meet their requirements for the 2010 application.

AO Museum Committee, Tim Carroll -

There are some issues with the executive leadership at the Museum with regards to the Association assets, but with the help of VADM Bowman we think we can resolve this issue. Capt Lepard will be traveling to Pensacola to meet with Mr. Macon to re-start the process.

Educational Foundation President – Ed Scott

During this year your Foundation continues to remain extremely active in all matters. With the end of FY 2008-2009 bestows the normal flurry of administrative requirements derived to determine the health of our Foundation both administratively and financially. In house reviews are required as well as reviews by outside agencies. We look forward to these reviews since we believe that they are tools that help us learn and improve.

As I look over the reports from FY 2008-2009 reviews I found that your Foundation was sound both administratively and financially; however there was room for improvement in both areas. In the administrative area responsibility for

updating and changing all our documents rested with one or two individuals, we have now assigned one or two documents to each Officer who is responsible for keeping them current. In the financial area we looked hard at the method used to calculate raises in scholarship amounts and also in their numbers. There was a complex formula to determine if raises could be made and still remain with the requirements in the Bylaws Article IX, Section 3. It was felt that tying raises to a percentage of interest earned would allow for more timely raises while still meeting the requirements; even in these rough economic times. These two changes will serve to make us even stronger.

We also found that there was an IRS rule that prevents the Officers of the Foundation from sponsoring or applying for a scholarship while in office and for five years there after; referred to "Disqualified Person" in numerous IRS directives. Upon learning of the problem we changed the Bylaws and the scholarship eligibility requirements. This also creates problems to volunteers, elections and to serve on the Foundation in all capacities; each faces an 8 year restriction; 3 office term + 5 there after term. Those who do serve do so with knowledge of this restriction and without pay. My hats off to each and every one who has or now serve on your Foundation.

Individual, Chapter, Auxiliary, CFC, and Corporate contributions were up and we thank you for your continued support. We welcome our new corporate player The PDI Group, thanks for your contribution and we hope to have you onboard for many years to come. No matter where you fall in these contributors you are important to us for without your support we would have been unable to continue to award scholarships. This past year at this convention we awarded 4 Robert L. Crow scholarships, 3 @ 3,500 and 1 @ 1,500; we also awarded a \$3,500 Northrop/Grumman scholarship and 4 Raytheon scholarships at \$1,000 each. Did you notice the addition of the \$1,500 Robert L. Crow Scholarship? We have not rested on the past performance and" status quo" this year due to CFC Campaign 2008 funding received we have budgeted and approved 3 @3,750, 1 @ 1,750 and 5 @1,500; we also expect to award a \$3,500 Northrop/Grumman Shipbuilding Division, Newport News scholarship and 4 Raytheon scholarships (14). In total scholarship award dollars available this year is \$20,500 in Robert L. Crow and \$7,500 in the name of corporate to 17 applicants that your scholarship committee will select. Did you again notice the additional Robert L. Crow Scholarships?

This year was our first experience as a receiver of CFC funds. As of May 31, 2009 we have received \$10,296 with around \$19,900 due by March 2010; the Foundation Treasurer will provide more information. All of this is from the 2008 CFC Campaign. We thank everyone who contributed to us through the 2008 CFC campaign. CFC is a yearly campaign and each year you must apply to be part of it. There is NO guarantee that you will be in year after year. I







Final GI Bill family transfer rules unveiled.

Service members can register to transfer their Post-9/11 GI Bill benefits

to family members beginning June 29, the Pentagon announced Tuesday. The program represents both the most significant expansion of

education benefits since they were first offered after World War II and, for service members with families, the most significant retention bonus offered since the start of the allvolunteer force. Most users will earn benefits payments spread over 36 months that will total between \$75,000 and \$90,000, the Pentagon estimates.

On June 29, a special Pentagon Web site will go live, allowing service members to securely apply to allow their immediate family members to share in their education benefits beginning Aug. 1, according to Bob Clark, the Defense Department's assistant accession policy director and the top official working on the new benefits plan. Service members who plan to use at least part of their benefit in the near future should first register through the Department of Veterans Affairs GI Bill Web site, Clark said. But those who do not plan to use their benefits anytime soon, or not at all, do not have to register with VA to apply for the family member benefit; they can simply register through the Pentagon site that will become active June 29.

Service members have up to 15 years from the time they leave the service to apply through VA for a Certificate of Eligibility, Clark said. Clark emphasized that service members must be on active duty or in the Selected Reserve on Aug. I to be eligible for family transfer rights. "Those who have retired, even if their last day on active duty was July 31st or anytime before that, or have separated or are in the IRR (Individual Ready Reserve) are not eligible for the transferability," he said. He noted that transferability was established "for the specific purpose of recruitment and retention of a career force." "Transferability of GI Bill benefits is the most requested initiative we receive from our ser-

vice members, and we believe it will assist us in retaining highly qualified military personnel,"

said Bill Carr, deputy undersecretary of defense for military personnel.

Service members will apply beginning June 29 through the transferability of Educational Benefits (TEB) website, which will be located at https://www.dmdc.osd.mil/TEB/. Service members will be able to securely access this site with their Common Access Card, a Defense Department Self Service User ID or a Defense Finance and Accounting Service PIN number, the Pentagon said. Clark asked that service members whose family members do not plan to take classes this fall to delay their registration by a couple of weeks - until at least July 15 - to allow those who do plan to do so to get through the registration process. The effective date will be Aug. 1 for all applicants, regardless of their application date, he said, and the services will have their hands full as they must each verify the information and, in many cases, process re-enlistments and service extensions. "We want the services to be able to prioritize their applications," Clark said. Once that is done, the services will pass the application to the Department of Veterans Affairs, Clark said. "At that point ... the family member will be treated by VA just as if they were a service member or veteran," he said.

Clark denied that a request for delayed applications is related to a fear of crashing computer servers; the Web site is being administered by the Defense Manpower Data Center, whose servers have "substantial" capability, he said. No changes have been made to the final rules previously announced; their implementation was delayed over a procedural matter that has been resolved, Clark said.

The final rules, according to the Pentagon, allow transferability of a portion or all of Post-9/11 GI Bill benefits for any member of the armed forces (active duty or Selected Reserve, officer or enlisted) on or after August 1, 2009, who is eligible for the benefit, and:* Has at least six years of service in the armed forces on the date of election and agrees to serve four additional years in the armed forces from the date of election.* Has at least 10 years of service in the armed forces (active duty and/or Selected Reserve) on the date of election, is precluded by either standard policy or statute from committing to four additional years, and agrees to serve for the maximum amount of time allowed by such policy or statute, or is or becomes retirement-eligible during the period from Aug 1, 2009, through Aug 1, 2013.


For those eligible for retirement on Aug 1, 2009, no additional service is required. For those who have an approved retirement date after Aug 1, 2009, and before July 1, 2010, no additional service is required. For those eligible for retirement after Aug 1, 2009, and before Aug 1, 2010, one year of additional service after approval of transfer is re-

quired. For those eligible for retirement on or after Aug 1, 2010, and before Aug 1, 2011, two years of additional service after approval of transfer are required. For those eligible for retirement on or after Aug 1, 2011, and before Aug 1, 2012, three years of additional service after approval of transfer required.

An individual approved to transfer an entitlement to educational assistance under this section may transfer the individual's entitlement to the individual's spouse, one or more of the individual's children, or any combination of spouse and child. A family member must be enrolled in the Defense Eligibility Enrollment Reporting System (DEERS) and be eligible for benefits at the time of transfer to receive transferred education benefits. A child's subsequent marriage will not affect his or her eligibility to receive the education benefit. However, after an individual has designated a child as a transferee under this section, the individual retains the right to revoke or modify the transfer at any time. A subsequent divorce also will not affect the transferee's eligibility to receive education benefits, but again, after an individual has designated a spouse as a transferee under this section, the eligible individual retains the right to revoke or modify the transfer at any time.


An eligible service member may transfer up to the total months of unusedPost-9/11 GI Bill benefits, or the entire 36 months if the member has used none. Spouses may start to use the benefit immediately, either while the member remains in the armed forces or for up to 15 years from the service member's separation from active duty. Spouses are not eligible for the Post-9/11 GI Bill's monthly book or living stipends while the member is serving on active duty.

Children may start to use the benefit only after the individual making the transfer has completed at least 10 years of service, either while the eligible individual remains in the military or after separation from active duty. Children may not use the benefit until they have attained a secondary school diploma (or equivalency certificate), or reached 18 years of age. They are entitled to the monthly book and fiving stipends even if the eligible individual is on active duty. Children may not use the benefit after reaching 26 years of age.






