As the Gunner stated, ensure you visit sick bay for virtually all work related injuries and have the visit recorded. You'll need that when filing for benefits upon departing the Service...

That also applies for tinnitus... When taking all those hearing tests over the years, I'd move the device over my ears around until I was able to hear the high frequency sound being emitted, ignoring the ringing that was always there... It never occurred to me that everyone's ears didn't ring as mine did (and still do)... So, during a pre-retirement briefing, it was mentioned that ringing in the ears was a problem from being around too much noise for too long. So, when I was getting my retirement physical, I mentioned it to the doctor and was told it didn't apply, as I had no record stating it was service connected... Had I ever gone to sick bay or even mentioned it during my many earlier physicals and had it documented in my health record, I'd be receiving some 15% service connected disability, come income tax time, forever...

Dear Kevin,

I am a member of the Association of Aviation Ordnancemen, and for the past year several of my ex squadron mates from VP65 have been working at Edwards Air Force Base, CA restoring an old Douglas A-3D1 Skywarrior that has been sitting abandoned on the base on an unused runway for over 40 years.

Please see attached photos of the plane as we found it in Jan of 2010, and how she looks today with our continued work.

We are restoring the airplane to present it to the Edwards Museum for the 100th Anniversary of Naval Aviation, hopefully in November of 2011. Since removing the airplane from the abandoned runway, we have moved it to a hangar which we share with a Marine helicopter detachment out of Miramar Marine Air Corps Station, CA. To date, besides giving the airplane an overdue bath, we have completely cleaned out the bomb bay, drained water from the wing tanks, installed three new tires, sanded the oxidized paint, repaired corrosion on the fuselage and engine cowlings, removed, cleaned, and reinstalled both engines, replaced both front cowlings, replaced oil coolers, installed ATM's, repaired the cockpit canopy with new glass, partially restored the cockpit, installed original avionic boxes, repaired and sanded the nose and aft radomes, currently seeking two M3 20MM machine guns, sandblasted the main mount struts, repaired the tailhook, locked the JATO hooks into the fuselage, and many other minor jobs too numerous to mention. 135434 will be painted in its original color of Midnight Blue when completed.

This particular A-3, BuNo 135434 was built in 1955, was assigned to VAH3 in Sanford, Fl, was then used in Operation Redwing to monitor and collect radiation data at Bikini Atoll, Eniwetok Atoll, and Kwajalein Atoll. It was then sent to PAX River for testing, then to Edwards Air Force Base for barrier tests, and airfoil tests. It was declared excess to the Navy in 1968, and has been parked at Edwards ever since.

The picture of the crew doing this work is of AFCM Mike Glenn and PR2 Pete Nowicki, kneeling, standing, ADC Andy Barbre, ADJ1 Ty Wilcox, AOC Delbert Mitchell, AMSC Bill Grant, and AO1 Delwynn Mitchell.

This is when we dig down deep and ask God for strength. I did ask those in attendance, "did we do all we could, did we see the signs, how could we have prevented As you read this short piece from your Vice-President, please take a proactive role in preventing suicides. Parents, listen to your kids and really hear what they may be saying. Know the signs, and ask yourself, what can I do and then act immediately. Don't wait until it's too late! Thank you all for allowing me to share this moment with you. I am looking forward to the year to come pray all our safety and prosperity. To all, have a safe and blessed New Year.

I look forward to seeing all of you at the convention.


### Chapter 21



# Life Saving Helo Gunner Submitted by Bob Holdman

Former AO3 Neil William McDonald served two tours as a door gunner flying UH-I Hueys with the HAL-3 Seawolves in Vietnam as a member of Det Six at Dong Tam. he logged over 650 combat missions during two in-country tours. he also served as both a second gunner and first gunner/crew chief on Det Two Army gunships. While all missions were high risk, two stand out in memory.

On 7 January 1969 two Vietnamese Regional Force Companies, known as Ruff Puffs, were ambushed and pinned down by the Viet Cong. They had sustained heavy causalities, both KIA and wounded, and were in imminent danger of being overrun. Det 6 scrambled two helos in support of the Ruff Puffs. Executing repeated tree top level strikes, McDonald laid down deadly fire against the concealed enemy. His helo drew continuous heavy weapons fire from the enemy.

Since no medevac team was available, McDonald's craft landed in the hot zone to evacuate the dead and wounded for transport to medical facilities. McDonald left his aircraft to provide covering fire, and also assisted in loading the casualities. he continued shooting as the gunship became airborne. The casualities were rushed to a medical unit where prompt medical attention saved the lives of many of the wounded.

Even though both gunships took numerous hits they rearmed and refueled several times which enabled the friendly forces to consolidate their position, regain control of the battle, and secure the area.

For this action, the Army awarded Neil McDonald the Distinguished Flying Cross.

On 26 March 1969 VC ambushed a unit of riverine patrol boats near Dong Tarn. Fire teams from Dets 4 and 6 launched and made repeated attacks against the VC, causing heavy causalities. The enemy disengaged after nightfall but later that night commenced a heavy barrage of mortars and rockets onto the base where the gunships were parked. An Army ammo dump where 172 tons of ordnance were stored, located 75 meters from the flight line, was hit and began burning.

In order to man their Hueys, the Seawolves raced through hails of flying shrapnel and hot cinders created by the incoming mortar and rocket rounds as well as the exploding ordnance from the ammo dump.

Just as the lead ship became airborne, the ammo dump ex-

ploded, slamming the lead bird to the ground. The pilot was ejected to the ground and pinned beneath the Huey.

In the trail helo McDonald was sitting just aft of the two pilots in the cockpit in order to expedite engine start procedures. An enemy round hit this aircraft, compressing the cockpit area and trapping the three airmen. Although stunned, McDonald extricated himself and crawled through the wreckage to his copilot. The second gunner helped shove the metal and debris away from the copilot and pulled him out and away from the wreckage. But the copilot died shortly thereafter. Next, the two crewmen pulled the badly wounded pilot out to a safe location.

Both crewmen then ran to the lead bird where the pilot was pinned beneath it. Fuel was dangerously flowing from a ruptured fuel cell. Standing ankle deep in the fuel, large chunks of shrapnel and fire rained around them. Aware the aircraft could explode at any moment, Det 6 's gunners were joined by several others who helped raise the chopper off the pilot, saving his life.

Inexplicably, the fuel did not ignite and both rescues were completed. After the crew left the area, the gunship caught fire. Neil McDonald had been badly burned during the rescue and was evacuated for treatment of his injuries. For his heroic actions, McDonald was honored with the Silver Star. Combat Aircrewman McDonald was inducted into the Enlisted Combat Aircrew Roll Of Honor in November 2003.







#### Aviation Ordnancemen:

- Are aircraft armament (weapons) specialists in charge of storing, servicing, inspecting and handling of all types of weapons and ammunition carried on Navy aircraft.
- These technicians may also volunteer to fly as Naval aircrew. Aircrew performs numerous in-flight duties and operates aircraft systems in turbojet, helicopter, or propeller aircraft.
- The duties performed by AOs include:
  - Inspect, maintains and repair aircraft mechani cal and electrical armament/ordnance systems;
  - Service aircraft guns and accessories;
  - Stow, assembles and load aviation ammunition including aerial mines, torpedoes, missiles and rockets;
  - Service bomb, missile and rocket releasing and launching devices;
  - Load supplementary munitions;
  - Assemble, tests and maintain air-launched guided missiles;
  - Supervise operation of aviation ordnance shops, armories and stowage facilities;
- Working Environment

AOs perform their duties at sea on flight decks and ashore in hangars, on flight lines at air stations, or in shops under various environmental conditions. They work closely with others, do mostly physical work and require little supervision.




